5.0 Managers Report

Bruce presented a proposed Budget for the 2022/2023 year. Due to the Covid restrictions we have had over the past few years it is difficult to identify a previous year to use as a comparator.

Cost have gone up as most things such as food, delivery costs have all increased. Changes will have to be made to the food pricing due to these higher costs. The Ninth End café continues to grow and has established regular and repeat customers. Bruce reported that the majority of the customers eating at the Ninth end Café are not curlers. This is a very good sign for the profitability of the restaurant.

Event rentals have not returned to pre pandemic levels as Covid restrictions were lifted in early spring and major events like weddings are usually booked 8 to 12 months in advance. The service groups of Rotary and Kiwanis continue to meet weekly.

Bruce has suggested that the Club trial a new 'Beer League' on Tuesday evenings at 9 pm. The Kelowna Curling Club introduced this concept to attract individuals who play in summer Beer leagues to a winter sport activity. Kelowna has found this to be very successful. Not only has the Beer league expanded to several nights each week, the league has successfully introduced curling to new individuals who have subsequently become Club members.

The Beer League will be a unique as the men and women in the league will not be required to become members of the Chilliwack Curling Club. There will be no limit on the numbers of players on the team roaster however the four players who start each game must finish the game. All games are six ends. The entry cost will be \$800.00 /team + GST. After discussing how this league will be structured, the Board agreed to support this innovative programme this fall (Motion moved by Elaine Christie and seconded by Rick Hunter- CARRIED) Bruce and his staff will begin to actively market this programme to the Summer Beer Leagues that are currently playing ball.

Terry Cross moved that the proposed budget presented by Bruce Renwick be accepted and seconded by Rick Hunter- CARRIED
